Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to klubhouserc.com, and Kiddies Klubhouse and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Kiddies Klubhouse include klubhouserc.com. The Kiddies Klubhouse website is a Childcare site. By using the Kiddies Klubhouse website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Kiddies Klubhouse may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Kiddies Klubhouse collects and uses your personal information to operate and deliver the services you have requested.

Kiddies Klubhouse may also use your personally identifiable information to inform you of other products or services available from Kiddies Klubhouse and its affiliates.

Sharing Information with Third Parties

Kiddies Klubhouse does not sell, rent or lease its customer lists to third parties.

Kiddies Klubhouse may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Kiddies Klubhouse, and they are required to maintain the confidentiality of your information.

Kiddies Klubhouse may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law

Tracking User Behavior

Kiddies Klubhouse may keep track of the websites and pages our users visit within Kiddies Klubhouse, in order to determine what Kiddies Klubhouse services are the most popular. This data is used to deliver customized content and advertising within Kiddies Klubhouse to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Kiddies Klubhouse. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Kiddies Klubhouse website.

Use of Cookies

The Kiddies Klubhouse website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
